The School must follow Uniform System of Assessment, Examination and Report Card for 3. classes VI-IX from Academic year 2017-18 onwards as per the Board's Circular No.Acad-

14/2017 dated 21/03/2017.

The school must submit it's information through Online Affiliated School Information 4. System (OASIS) as per the Board's Circular No.CBSE/Aff./4/Circular/2016 dated 10/11/2016 within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website:" www.cbse.nic.in

The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text 5. books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.

The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective 6.

State /UT Govt from time to time.

The school will enroll students proportionate to the facilities available in the school as prescribed in 7. the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII:-

Secondary School 2000 sq. mtr. 600 upto Class X Sr. Secondary School with two streams 3000 sq. mtr. 900 to Class XII

The school should scrupulously observe prescription from the Municipal Authority/District Collectorate/Transport Department regarding drinking water, fire safety and transport precautions in the school. A certificate from the Municipal/Fire/transport Authority regarding sanitary condition water/fire/transport safety should be submitted every five years as per Rule 8.5 of Affiliation E Laws and shall follow Rule no: 3.3(vii) and Rule 23(xi) in this regard.

41. The school shall enter into an agreement with the Board detailing the terms and conditions for grant of affiliation, which will be binding on both the parties. 42. Special conditions to be complied within three months:-

a) School Managing Committee is to be re-constituted as per Rule 20 of Affiliation Bye-laws, by including 02 representatives each of teachers and parents, 2 CBSE representatives from KVs/JNVs not below the rank of Principal of Sr. Secondary School affiliated with the Board subject to recommendation of the Board and also ensure that no blood relation is in it.

b) School is required to ensure that no teacher in the school should work after his/hersuperannuation.

The school is required to furnish valid Health & Sanitary, Safe-Drinking Water, Building c) Safety and Fire Safety Certificates issued by the competent authorities/concerned department.

d) The school is required to submit a renewal copy of EPF. A documentary proof regarding implementation and regular deduction of EPF is required to be submitted alongwith latest Pay Bill and Bank Challan.

The school is required to renewal the reserve fund as per strength of the school and in the e) joint names of Secretary, CBSE and Manager of the school as per provisions of Affiliation Bye-Laws of the Board and copy of FDR may be furnished to the Board for record purpose.
